### **General Instructions for B.Pharm Admission as per Maharashtra State CET Cell**

1. Admission is provisional and subject to verification of all original documents and eligibility criteria prescribed by the CET Cell.
2. Candidates must carefully verify their name, qualifying examination marks, category, reservation, gender and other details entered in the application form and merit list.
3. Admission to direct second year B.Pharm is subject to the eligibility criteria prescribed by the CET Cell, including passed D.Pharm (Diploma in Pharmacy) from PCI-approved institute, as notified for the academic year.
4. Candidates allotted a seat through the CAP Round must complete the admission and reporting process within the prescribed schedule.
5. The candidate must submit the original documents and required copies for verification at the time of admission.
6. Candidates claiming reserved category benefits must produce valid and applicable certificates, such as Caste Certificate, Caste Validity Certificate, Non-Creamy Layer Certificate, EWS Certificate, PWD Certificate, etc., wherever applicable. CET Cell instructions specify further verification requirements for candidates who initially submitted receipts for certain certificates.
7. The admission fee must be paid as applicable, according to the approved fee structure and candidate category.
8. Admission will be confirmed only after successful document verification, payment of fees, fulfilment of eligibility conditions and completion of all CET Cell requirements.
9. Any incorrect information, false certificate or suppression of facts may result in cancellation of admission at any stage.
10. Candidates should regularly check the official B. Pharmacy Admission Portal for CAP notices, schedules, merit lists, seat allotment and other updates.
11. Do not rely on admission agents or unauthorized intermediaries. For institute-level and vacant-seat admissions, the CET Cell has emphasized adherence to the prescribed merit-based procedure.
